Call for Abstract

Dignity, both of the person receiving care and of the caregiver, is a central construct for the nursing profession and is explicitly referenced in many international codes of ethics. Nevertheless, it remains a concept that is difficult to study, communicate, and safeguard in the everyday practices of clinicians, educators, and healthcare managers. This second conference of the *Centro Interuniversitario per la Ricerca sull'Etica Infermieristica* (Interuniversity Centre for Research on Nursing Ethics) aims to explore the different ontological, professional, and ethical dimensions of dignity to provide the nursing profession with a meaningful framework for addressing the challenges posed by the current healthcare context. Rediscovering the fundamental values of care may help nurses understand the universal dimension of their work and provide them with important analytical tools.

The Scientific Committee of the 2nd CIREI Conference “Dignity and Care Today – Ethical Perspectives for the Nursing Profession” invites professionals, researchers, academics, and students to submit abstracts presenting scientific contributions and experiential reflections on the theme of dignity in nursing care.

Abstracts may address (but are not limited to) the following topics:

- Ethical and philosophical foundations of dignity in care
- Professional experiences and best practices in promoting dignity
- Dignity and vulnerability: care approaches in situations of frailty
- Nursing education and the development of ethical sensitivity
- Dignity and healthcare management
- Tools for the assessment and monitoring of perceived dignity
- Narratives and experiences of patients, families, and professionals
- Intersections between dignity, social justice, and health inequalities
- Innovative experiences and projects in clinical, educational, or organisational settings

Abstracts (in Italian or English) must include:

- Title, Author(s) (name, surname, affiliation, email), Abstract text (maximum 300 words, Word or PDF format), Keywords (maximum 5), Type of contribution: Professional experience / Case study / Empirical research / Qualitative or quantitative study

All abstracts will be reviewed anonymously by the Scientific Committee. Authors of selected abstracts will receive notification of acceptance by 1 March 2026.

Accepted poster contributions will be presented during the travelling poster session of the conference (12:30 – 14:00), encouraging direct interaction between participants and authors.
